ANNOUNCEMENT

SG Issuer (the “**Issuer**”) refers to its announcement dated 13 August 2020 in relation to its designated market-maker, Société Générale (the “**Designated Market Maker**”), providing a continuous bid while making intermittent offers over the European Style Cash Settled Short Certificates relating to the ordinary shares of Tencent Holdings Limited with a Daily Leverage of -5x (Stock Code: DDJW) (the “**Certificates**”) until 3 September 2020 as the Issuer had sold all of its inventory in the Certificates as at 2:09 p.m. on 12 August 2020.
