ANNOUNCEMENT

RESULTS OF THE PREFERENTIAL OFFERING BY MAPLETREE LOGISTICS TRUST

Capitalised terms used herein, but not otherwise defined, shall have the meanings ascribed to them in the announcement of Mapletree Logistics Trust dated 23 November 2021 titled "Launch of Equity Fund Raising to Raise Gross Proceeds of Approximately S\$700.0 million" (the "Launch Announcement").

1. INTRODUCTION

Further to the Launch Announcement and the announcements dated 23 November 2021, 24 November 2021, 2 December 2021 and 6 December 2021, in relation to, among other things, the non-renounceable preferential offering of 159,109,907 New Units on the basis of 37 New Units for every 1,000 Existing Units held as at 5.00 p.m. on 1 December 2021 to Eligible Unitholders¹ (fractions of a New Unit to be disregarded) at an issue price of S\$1.84 per New Unit (the "**Preferential Offering**"), Mapletree Logistics Trust Management Ltd., in its capacity as manager of MLT (the "**Manager**"), wishes to announce that valid acceptances and excess applications for a total of 212,860,557 New Units, representing approximately 133.8% of the total number of New Units available under the Preferential Offering, were received as at the close of the Preferential Offering on 14 December 2021. Details of the valid acceptances and excess applications received are as follows:

The balance of 30,980,757 New Units which were not validly accepted will be allotted to satisfy applications for Excess New Units. In the allotment of Excess New Units, preference will be given to the rounding of odd lots. The Manager, directors of the Manager (the "**Directors**") and substantial Unitholders who have control or influence over MLT or the Manager in connection with the day-to-day affairs of MLT or the Manager or the terms of the Preferential Offering, or have representation (direct or through a nominee) on the board of Directors will rank last in priority for the rounding of odd lots and allotment of Excess New Units.

A total of 159,109,907 New Units will be issued pursuant to the Preferential Offering at the issue price of S\$1.84 per New Unit to raise gross proceeds of approximately S\$292.8 million.

¹ "**Eligible Unitholders**" means (a) the Eligible Depositors and (b) the Eligible QIBs.

Together with the gross proceeds of approximately S\$400.0 million raised from the Private Placement, gross proceeds of a total of approximately S\$692.8 million have been raised from the Equity Fund Raising.

2. COMMITMENT BY THE SPONSOR

Pursuant to the Undertaking provided by Mapletree Investments Pte Ltd, the sponsor of MLT (the “**Sponsor**”), which owned an aggregate interest of approximately 31.59% of the total number of Units in issue through its wholly-owned subsidiaries prior to the launch of the Equity Fund Raising, the wholly-owned subsidiaries of the Sponsor, namely Mulberry Pte. Ltd., Meranti Investments Pte. Ltd., Mapletree Logistics Properties Pte. Ltd., Mangrove Pte. Ltd., Mapletree Logistics Trust Management Ltd. (in its own capacity) (the “**MIPL Subsidiaries**”), have accepted in full their respective provisional allotments of an aggregate of 50,264,772 New Units under the Preferential Offering.

Immediately post-completion of the Preferential Offering, the Sponsor will have an aggregate deemed interest in 1,408,772,194 Units, representing approximately 30.15% of the total number of 4,672,143,672 Units in issue after the listing and quotation of the 159,109,907 New Units issued pursuant to the Preferential Offering.

3. REFUNDS

In relation to any void or invalid acceptances of New Units or any unsuccessful applications for Excess New Units under the Preferential Offering, all monies received in connection therewith will be returned by CDP on behalf of MLT to the Eligible Unitholders, without interest or any share of revenue or other benefit arising therefrom, by any or a combination of the following means:

- (a) by crediting their designated bank accounts via CDP’s Direct Crediting Service (if they had applied for Excess New Units under the Preferential Offering through CDP). In the event that they are not subscribed to CDP’s Direct Crediting Service, any monies to be refunded will be retained by CDP and reflected under the Cash Transaction section of their CDP monthly account statements; or
- (b) by crediting their accounts with the relevant Participating Banks² (where acceptance and/or application is made through Electronic Applications), within three (3) business days after the commencement of trading of the New Units on 22 December 2021,

and in each case at the Eligible Unitholders’ own risk.

2 “**Participating Banks**” means DBS Bank Ltd., Oversea-Chinese Banking Corporation Limited and The Hongkong and Shanghai Banking Corporation Limited, Singapore Branch.

4. STATUS OF THE NEW UNITS TO BE ISSUED PURSUANT TO THE PREFERENTIAL OFFERING

The Manager expects the New Units issued pursuant to the Preferential Offering to be listed and quoted on the Main Board of the SGX-ST with effect from **9.00 a.m. on 22 December 2021**.

The New Units issued pursuant to the Preferential Offering will, upon issue, rank *pari passu* in all respects with the Units in issue on the day immediately prior to the date on which the New Units are issued pursuant to the Preferential Offering, including the right to the Relevant Period Distribution as well as all distributions thereafter, other than in respect of the Advanced Distribution.

For the avoidance of doubt, the holders of the New Units to be issued pursuant to the Preferential Offering will not be entitled to the Advanced Distribution.

The Manager wishes to take this opportunity to thank Unitholders for their support in ensuring the successful completion of the Preferential Offering.
