Notice of Record Date and Payment Date for Final Dividend

As at the date of this announcement, Tianjin Zhong Xin Pharmaceutical Group Corporation Limited (the “**Company**”) has an issued share capital in aggregate of 773,443,076 shares, comprising 573,443,076 ordinary shares issued by the Company under the companies law promulgated by the People's Republic of China (the “**PRC**”) to natural and legal persons in the PRC, and which are denominated in renminbi (the “**A-Shares**”), and 200,000,000 ordinary shares issued by the Company to natural and legal persons in countries other than PRC, and which are denominated in United States dollars (the “**S-Shares**”). For the purpose of this announcement, A-Shares and S-Shares shall collectively be referred to as the **Shares**.

Further to the announcements released by the Company on 30 March 2022, 22 April 2022 and 16 May 2022, notice is hereby given that the Share Transfer Books and Register of Members of the Company will be closed after 5.00 p.m. on 25 May 2022 (for S-Shares) and 1 June 2022 (for A-Shares) for the purposes of determining shareholders' entitlements to the final dividend of RMB50 cents per ordinary Share (the “**Final Dividend**”). The Final Dividend for the financial period ended 31 December 2021, which was approved by shareholders of the Company (the “**Shareholders**”) at the Company's annual general meeting held on 16 May 2022, is subject to applicable tax rates as set out below:

(1) S-Shares

The dividend payable to S-Shareholders shall be subject to a tax rate of 10% under the PRC tax law.

(2) A-Shares

The dividend payable to A-Shareholders shall be subject to the differential tax rates as set out in the PRC tax law. A-Shareholders should consult their own tax advisers concerning the tax consequences in relation to any dividends paid by the Company.

Duly completed registrable transfers in respect of the Shares together with all relevant documents of title received by the Company's S-Shares Share Registrar, Boardroom Corporate & Advisory Services Pte. Ltd., at 1 Harbourfront Avenue, Keppel Bay Tower #14-07 Singapore 098632 up to the close of business at 5.00 p.m. on 25 May 2022 will be registered to determine S-Shares Shareholders' entitlement to the Final Dividend.

Shareholders whose securities accounts with The Central Depository (Pte) Limited (“**CDP**”) are credited with Shares as at 5.00 p.m. on 25 May 2022 will be entitled to the Final Dividend.

The Final Dividend is expected to be paid on or about 2 June 2022.
