**PAYMENT OF MANAGEMENT FEES
BY WAY OF ISSUE OF NEW UNITS IN ESR-REIT**

ESR Funds Management (S) Limited, as the manager of ESR-REIT (the “**Manager**”), wishes to announce that 6,138,258 new units in ESR-REIT (“**Units**”) have been issued to the Manager (4,143,055 new Units) and ESR Property Management (S) Pte Ltd, the property manager of ESR-REIT (the “**Property Manager**”) (1,995,203 new Units) today.

The new Units were allotted at an issue price of S\$0.4132 per Unit as partial payment for the Manager's base fees and the Property Manager's property management fees for the period from 1 April 2021 to 30 June 2021 (“**2Q2021**”).

The issue price was determined based on the volume weighted average price for a Unit for all trades done on the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) in the ordinary course of trading on the SGX-ST for the last ten (10) business days of 2Q2021.

Following the above issuance of new Units, the total number of Units in issue is 4,007,446,385 of which the Manager's holding is 33,061,223 Units and the Property Manager's holding is 13,812,221 Units, representing 0.82% and 0.34% of the total number of Units in issue, respectively.

ESR-REIT has been listed on the Singapore Exchange Securities Trading Limited since 25 July 2006.

ESR-REIT invests in quality income-producing industrial properties and as at 30 June 2021 holds interest in a diversified portfolio of 58 properties located across Singapore, with a total gross floor area of approximately 15.6 million square feet and an aggregate property value of S\$3.2 billion¹. The properties are in the following business sectors: Business Park, High-Specs Industrial, Logistics/Warehouse and General Industrial, and are located close to major transportation hubs and key industrial zones island-wide. ESR-REIT also holds a 10.0% interest in ESR Australia Logistics Partnership, a private fund comprising 37 predominantly freehold logistics properties all located in Australia.

The Manager's objective is to provide Unitholders with a stable income stream through the successful implementation of the following strategies:

- Acquisition of value-enhancing properties;
- Proactive asset management;
- Divestment of non-core properties; and
- Prudent capital and risk management.

ESR Funds Management (S) Limited, the Manager of ESR-REIT, is owned by namely, ESR Cayman Limited ("ESR") (67.3%), Shanghai Summit Pte. Ltd. (25.0%), and Mitsui & Co., Ltd (7.7%).
