<p>1. We refer to the announcements made by IHH Healthcare Berhad (“IHH”) on 5 January 2022, 28 January 2022 and 5 April 2022 (“<b>Announcements</b>”) in relation to the Suit filed by Emqore against, among others, IHH. Unless otherwise stated, the definitions used herein shall have the same meanings as set out in the Announcements.</p> <p>2. The Board of Directors of IHH wishes to announce that, on 7 September 2022 (Eastern Standard Time), the United States Federal District Court for the District of New Jersey (“<b>New Jersey District Court</b>”) has granted IHH's motion to dismiss Emqore's Amended Complaint subject to the right of the parties upon good cause shown to reopen this action if there is a failure to comply with the following conditions:</p> <p>“(a) Defendants consent to the jurisdiction of Indian courts and agree to accept service of process in India in any civil action timely filed by Emqore on their claims in this matter;</p> <p>(b) Defendants consent to waive any statute of limitations defenses that would not have applied as of the date of filing of this action.”</p> <p>(collectively known as the “<b>Order</b>”).</p>	

3. IHH is also advised by its US Counsel that Emqore has a right to appeal against the Order to the Court of Appeals for the Third Circuit, provided a notice of appeal is filed within 30 days of the Order.

4. IHH is still in the midst of seeking legal advice on the appropriate next steps to be taken in respect of the Order and in the event of an appeal by Emqore.

5. IHH will make further announcement as and when there are material developments on the above matter.
