The Company has completed its renounceable non-underwritten rights issue ("Rights Issue") of up to 530,653,662 new ordinary shares of par value US\$0.01 each in the capital of the Company ("Rights Shares") at an issue price of S\$0.014 for each Rights Share, on the basis of nine (9) Rights Shares for every ten (10) existing ordinary shares of par value US\$0.01 each in the capital of the Company ("Shares") held as at the record date of 5:00pm on 20 July 2026,

fractional entitlements to be disregarded.

The shareholding percentages immediately before and after the transaction are calculated based on the Company's total issued share capital consisting of 589,615,183 Shares and 924,128,338 Shares respectively.

This announcement replaces the Form 1 disclosure dated 17 August 2026 made by Mr Francis Tjia in connection with the subscription of shares by Octo Holdings Limited pursuant to the Rights Issue.

As previously disclosed on 17 August 2026, Octo Holdings Limited had subscribed for 320,800,679 Rights Shares. The correct number of Rights Shares subscribed for by Octo Holdings Limited is 320,800,659 Rights Shares. The discrepancy in the earlier disclosure was attributable to an error in the acceptance process of the Rights Issue made through the broker, which Mr Francis Tjia and Octo Holdings Limited became aware of only subsequent to the earlier disclosure and prior to the date of this replacement announcement.
