1. INTRODUCTION

The primary purpose of this Circular is to provide Shareholders with information in respect of the resolutions to be proposed at the Annual General Meeting for, among others, (1) the re-election of the retiring Director and the retirement of an Independent Non-Executive Director; (2) the appointment of an Independent Non-Executive Director; (3) the General Share Issue Mandate; and (4) the annual mandate to issue Shares under the ISDN PSP. For the avoidance of doubt, the aggregate number of new Shares issued under the General Share Issue Mandate and the PSP Annual Mandate shall not exceed 50% of the total number of issued Shares (excluding treasury shares and subsidiary holdings, if any) as at the date of the passing of the resolutions relating to the General Share Issue Mandate and the PSP Annual Mandate, of which the aggregate number of Shares to be allotted and issued other than on a *pro rata* basis to Shareholders shall not exceed 20% of the total number of issued Shares (excluding treasury shares and subsidiary holdings, if any) as at the date of the passing of the resolutions relating to the General Share Issue Mandate and the PSP Annual Mandate.

2. RE-ELECTION OF THE RETIRING DIRECTOR AND RETIREMENT OF INDEPENDENT NON-EXECUTIVE DIRECTOR

In accordance with Regulation 89 of the Constitution, Mr. Toh Hsiang-Wen Keith (“**Mr. Toh**”) and Mr. Tan Soon Liang (“**Mr. Tan**”) shall retire at the Annual General Meeting (collectively, the “**Retiring Directors**” and each, a “**Retiring Director**”).

In reviewing the nomination of Mr. Toh, the Nominating Committee considered his performance and contributions during the year, having regard not only to his attendance and participation at Board and Board Committee meetings but also the time and effort devoted to the Group’s business and affairs. The Board believes that the continuous appointment of Mr. Toh contributes to the stability and diversity of the Board.

Mr. Toh, being eligible, shall offer himself for re-election at the Annual General Meeting. For good corporate governance, Mr. Toh has abstained from voting at the relevant Board and Board Committee meetings on the proposition of his recommendation for re-election by the Shareholders.

Pursuant to Rule 210(5)(d)(iv) of the SGX-ST Listing Manual, a director will not be independent if he has been a director of the issuer for an aggregate period of more than nine years (whether before or after listing). However, such director may continue to be considered independent until the conclusion of the next annual general meeting of the issuer.

Mr. Tan was appointed as an Independent Non-Executive Director on 18 August 2016 and has served as an Independent Non-Executive Director for 9 years. Accordingly, following the conclusion of the Annual General Meeting, Mr. Tan will no longer be considered independent.

Mr. Tan has indicated that he will not be seeking re-election at the Annual General Meeting. Accordingly, at the conclusion of the Annual General Meeting, he will also cease to be the Chairman of the Board of Directors, and a member of the Audit Committee, Remuneration Committee and Risk Management Committee.

The information required to be disclosed under the Hong Kong Listing Rules and SGX-ST Listing Manual in relation to Mr. Toh’s proposed re-election at the Annual General Meeting is set out in Appendix I and Appendix II to this Circular.

3. APPOINTMENT OF AN INDEPENDENT NON-EXECUTIVE DIRECTOR

Following the retirement of Mr. Tan, and in accordance with Regulation 91 of the Constitution, the following individual is proposed to be appointed as an Independent Non-Executive Director at the Annual General Meeting:

Mr. Lim Teck Chai Danny (“**Mr. Lim**”)

As at the Latest Practicable Date, Mr. Lim does not have any interest in the Shares, underlying shares or debentures of the Company.

Pursuant to Regulation 93 of the Constitution, Assetraise, being a Shareholder of the Company, has provided notice in writing to the Company of its intention to propose for the above individual to be appointed at the Annual General Meeting (“**Nomination Notice**”). Mr. Lim has in turn, given notice to the Company of his consent to such nomination, following such intention of Assetraise to nominate him as an Independent Non-Executive Director of the Company (“**Notice of Consent**”).

In reviewing the nomination of Mr. Lim, the Nominating Committee considered the qualifications and work experience of Mr. Lim and is of the view that Mr. Lim possesses the requisite experience and capabilities to assume the responsibilities as an Independent Non-Executive Director. The Board having reviewed and considered the Nominating Committee’s assessment of Mr. Lim, is also of the view that Mr. Lim possesses the requisite experience and capabilities to assume the responsibilities as an Independent Non-Executive Director. The Board considers Mr. Lim to be independent for the purposes of Rule 704(8) of the SGX-ST Listing Manual and Rule 3.13 of the Hong Kong Listing Rules.

Mr. Lim has confirmed to the Company that, at the time of his proposed appointment, (i) he has met the independence criteria as set out in Rule 3.13 of the Hong Kong Listing Rules as well as the independence criteria as set out in Rule 210(5)(d) of the SGX-ST Listing Manual; (ii) he has no past or present financial or other interest in the business of the Company or its subsidiaries or any connection with any core connected person (as defined under the Hong Kong Listing Rules) of the Company; and (iii) there are no other factors that may affect his independence.

Mr. Lim, being eligible, shall offer himself for election at the Annual General Meeting.

Following the proposed appointment of Mr. Lim as an Independent Non-Executive Director of the Company as well as the retirement of Mr. Tan, the Board and Board Committees is intended to be re-constituted as follows:

4. GENERAL MANDATE TO ISSUE NEW SHARES

At the annual general meeting of the Company held on 30 April 2025, Shareholders granted a general and unconditional mandate authorising the Directors to allot, issue or deal with Shares, subject to and in accordance with the terms and conditions of the mandate. The existing General Share Issue Mandate shall expire at the conclusion of the Annual General Meeting.

A resolution relating to the General Share Issue Mandate (i.e. Ordinary Resolution 7 contained in the Notice of Annual General Meeting which is set out on pages 34 to 35 of this Circular) shall be proposed at the Annual General Meeting:

"That pursuant to Section 161 of the Companies Act 1967 of Singapore (the "Act"), the listing manual (the "SGX-ST Listing Manual") of the Singapore Exchange Securities Trading Limited (the "SGX-ST"), the Rules Governing the Listing of Securities (the "Hong Kong Listing Rules") on The Stock Exchange of Hong Kong Limited (the "SEHK") and the constitution of the Company, authority be and is hereby given to the Directors of the Company to:

- (a) (i) *allot and issue new shares in the capital of the Company ("Shares"), whether by way of rights, bonus or otherwise; and/or*
- (ii) *make or grant offers, agreements or options (collectively "Instruments" and each, an "Instrument") that might or would require Shares to be allotted and issued, during the continuance of such authority or thereafter, including but not limited to the creation, allotment and issue of (as well as adjustments to) warrants, debentures or other instruments convertible into Shares,*

at any time and upon such terms and conditions and for such purposes and to such persons as the Directors of the Company may, in their absolute discretion, deem fit; and

- (b) *allot and issue new Shares in pursuance of any Instrument made or granted by the Directors of the Company while this Resolution was in force (notwithstanding that such allotment and issue of Shares in pursuance of any Instrument may occur after the authority conferred by this Resolution may have ceased to be in force),*

PROVIDED ALWAYS THAT subject to any applicable regulation as may be prescribed by the SGX-ST and the SEHK:

- (A) the aggregate number of Shares to be allotted and issued pursuant to this Resolution (including Shares to be allotted and issued in pursuance of Instruments made or granted pursuant to this Resolution) does not exceed 50% of the total number of issued Shares excluding treasury shares and subsidiary holdings in the capital of the Company (as calculated in accordance with sub-paragraph (B) below), of which the aggregate number of Shares to be allotted and issued other than on a pro rata basis to shareholders of the Company (including Shares to be allotted and issued in pursuance of Instruments made or granted pursuant to this Resolution) does not exceed 20% of the total number of issued Shares excluding treasury shares and subsidiary holdings in the capital of the Company (as calculated in accordance with sub-paragraph (B) below);*
- (B) (subject to such manner of calculation as may be prescribed by the SGX-ST and the SEHK) for the purpose of determining the aggregate number of Shares that may be allotted and issued under sub-paragraph (A) above, the percentage of the total number of issued Shares excluding treasury shares and subsidiary holdings shall be based on the total number of issued Shares excluding treasury shares and subsidiary holdings in the capital of the Company at the time of the passing of this Resolution, after adjusting for:*
 - (I) new Shares arising from the conversion or exercise of the Instruments or any convertible securities;*
 - (II) new Shares arising from exercising share options or vesting of share awards, provided the options or awards were granted in compliance with the rules of the Listing Manual of the SGX-ST and the Hong Kong Listing Rules; and*
 - (III) any subsequent bonus issue, consolidation or subdivision of Shares;*

Any adjustments made in accordance with sub-paragraph (B)(I) and (B)(II) above shall only be made in respect of new Shares arising from convertible securities and Instruments which were issued and outstanding and/or subsisting at the time of the passing of this Resolution.
- (C) in exercising the authority conferred by this Resolution, the Company shall comply with the provisions of the Act, the SGX-ST Listing Manual (unless such compliance has been waived by the SGX-ST), the Hong Kong Listing Rules (unless such compliance has been waived by the SEHK) and the constitution of the Company; and*
- (D) the authority conferred by this Resolution shall continue in force until the earlier of:*
 - (I) the conclusion of the next annual general meeting of the Company;*
 - (II) the date by which the next annual general meeting of the Company is required by law to be held; and*
 - (III) the revocation or variation of the authority conferred by this Resolution by ordinary resolution passed by shareholders of the Company in general meeting."*

As at the Latest Practicable Date, the Company had 453,402,040 Shares in issue and the maximum number of new Shares that can be allotted and issued other than on a *pro rata* basis to Shareholders is 90,680,408 Shares representing 20% of the Shares in issue (excluding treasury shares and subsidiary holdings) (assuming no Share is allotted and issued or repurchased after the Latest Practicable Date and up to the passing of the resolution relating to the General Share Issue Mandate).

As at the Latest Practicable Date, the Company does not have any outstanding convertibles and share awards under the ISDN PSP. Accordingly, no new Shares will be allotted and issued pursuant to a conversion of convertibles or a vesting of share awards.

The grant of the General Share Issue Mandate provides the Directors with the flexibility to allot and issue new Shares when it is in the interests of the Company.

IMPORTANT: Notwithstanding the grant of the General Share Issue Mandate, the Company shall from time to time comply with the relevant requirements under Chapter 8 of the SGX-ST Listing Manual and the Hong Kong Listing Rules in relation to the issuance of securities, and in particular, Rules 7.19A(1) and 13.36 of the Hong Kong Listing Rules.

5. PSP ANNUAL MANDATE

At the extraordinary general meeting of the Company held on Tuesday, 31 January 2023 at 9.30 a.m., Shareholders approved the adoption of the ISDN PSP.

At the annual general meeting of the Company held on 30 April 2025, Shareholders granted an annual mandate to issue new Shares under the ISDN PSP authorising the Directors to allot and issue new Shares up to an aggregate number not exceeding 3% of the total number of issued Shares excluding treasury shares and subsidiary holdings in the capital of the Company as at the date of the passing of the resolution relating to the annual mandate to issue new Shares under the ISDN PSP. The existing PSP Annual Mandate shall expire at the conclusion of the Annual General Meeting.

A resolution relating to the PSP Annual Mandate (i.e. Ordinary Resolution 8 contained in the Notice of Annual General Meeting which is set out on page 35 of this Circular) shall be proposed at the Annual General Meeting:

“That subject to and conditional upon the passing of Ordinary Resolution 7 contained in this Notice of Annual General Meeting (the “General Share Issue Mandate”) and the Singapore Exchange Securities Trading Limited (the “SGX-ST”) granting the listing of, and permission to deal in, such number of new shares in the capital of the Company (“Shares”) which may be allotted and issued under the performance share plan of the Company (the “ISDN PSP”):

- (a) the aggregate number of new Shares underlying all PSP Awards granted by the Directors of the Company pursuant to this Resolution (excluding PSP Awards that have lapsed or been cancelled in accordance with the rules of the ISDN PSP) shall not exceed 3% of the total number of Shares in the issued share capital of the Company (excluding treasury shares and subsidiary holdings) on the day preceding the date on which the Shares are issued;*
- (b) authority be and is hereby given to the Directors of the Company to grant PSP Awards, allot and issue new Shares, procure the transfer of and otherwise deal with Shares under the ISDN PSP during the Relevant Period (as defined under sub-paragraph (c) below); and*
- (c) for the purposes of this Resolution, “Relevant Period” means the period from the passing of this Resolution until the earlier of:*
 - (i) the conclusion of the next annual general meeting of the Company;*
 - (ii) the date by which the next annual general meeting of the Company is required by law to be held; and*
 - (iii) the revocation or variation of the authority conferred by this Resolution by ordinary resolution passed by shareholders of the Company in general meeting.*

For the avoidance of doubt, the aggregate number of new Shares issued under the General Share Issue Mandate and this Resolution shall not exceed 50% of the total number of issued Shares as at the date of the passing of the resolutions relating to the General Share Issue Mandate and this Resolution, of which the aggregate number of Shares to be allotted and issued other than on a pro rata basis to shareholders of the Company shall not exceed 20% of the total number of issued Shares as at the date of the passing of the resolutions relating to the General Share Issue Mandate and this Resolution.”

As at the Latest Practicable Date, the Company had 453,402,040 Shares in issue and the maximum number of new Shares that can be allotted and issued under the PSP Annual Mandate during the period between the Annual General Meeting and the next annual general meeting of the Company or such earlier date as referred to in the resolution relating to the PSP Annual Mandate is 13,602,061 Shares representing 3% of the Shares in issue (excluding treasury shares and subsidiary holdings) (assuming no Share is allotted and issued or repurchased after the Latest Practicable Date and up to the passing of the resolution relating to the PSP Annual Mandate). An application will be made to the SGX-ST for listing of, and permission to deal in, the new Shares allotted and issued under the ISDN PSP.

Under the Hong Kong Listing Rules, Mr. Teo Cher Koon, Ms. Thang Yee Chin, Mr. Kong Deyang, Mr. Tan, Mr. Toh, Ms. Heng Su-Ling Mae and Mr. Sho Kian Hin are deemed to be connected persons of the Company. Any grant of share awards under the ISDN PSP to any connected persons shall be subject to Chapter 17 of the Hong Kong Listing Rules which prescribes, where applicable, announcement, circular, independent financial advice and disinterested shareholders' approval requirements relating to share schemes.

Therefore, each of TF, FF and TH is deemed to be interested in the 39,309,827 Shares held by NTSP pursuant to SFO. Non-Executive Director: Mr. Toh Hsiang-Wen Keith

Mr. Toh Hsiang-Wen Keith (“**Mr. Toh**”), aged 51, is our non-executive Director. Mr. Toh is a Partner and Director at Novo Tellus Capital Partners, an investment firm focused on technology and industrials investments globally. Mr. Toh has held numerous board positions with technology companies worldwide over the last two decades. Mr. Toh serves as Chair of SP Manufacturing Pte. Ltd., Chair of TDConnex Global Pte. Ltd.. In addition, Mr. Toh is a Director on the boards of several other private companies, including NT Thor Pte. Ltd. and NT Thor Holdings Pte. Ltd.. Mr. Toh was formerly a Principal at Francisco Partners, a global technology-focused private equity firm, where he focused on investments in global technology sectors including advanced manufacturing, industrial automation, software and cloud infrastructure, semiconductors, and optical communications. Earlier in his career, Mr. Toh was a product lead at Trilogy Enterprise Inc, an enterprise software company, and held engineering research roles at Stanford University and at the Ministry of Defence of Singapore.

Mr. Toh holds a Bachelor of Science in Electrical Engineering from Stanford University.

Mr. Toh has entered into a letter of appointment with the Company on 10 May 2025 for compliance with the Corporate Governance Code as set out in Appendix C1 to the Hong Kong Listing Rules for a term of three (3) years commencing from 10 May 2025 and he is entitled to an annual director’s fee of S\$50,820. For the financial year ended 31 December 2025, the total amount of his emoluments was approximately S\$50,820 which was paid to New Earth Group 2 Ltd. Mr. Toh is subject to the provisions of retirement by rotation at least once every three (3) years and re-election in accordance with the Constitution. The Director’s fee was determined with reference to the prevailing market conditions, his duties and responsibilities in our Company. The amount of Director’s fee is subject to Shareholders’ approval at the Annual General Meeting of the Company.

As at the Latest Practicable Date, Mr. Toh is deemed to have interest in the 39,309,827 Shares under the provision of Divisions 2 and 3 of Part XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) by virtue of his beneficial ownership in New Earth Group 2 Ltd, the general partner of Novo Tellus PE Fund 2, L.P. whose wholly-owned subsidiary NTCP SPV VI (a substantial shareholder of the Company) owns 39,309,827 Shares.

Save as disclosed above, Mr. Toh does not (i) hold any directorships in the last three years in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas; (ii) have any other major appointments or professional qualifications; (iii) hold any position in the Company or any of its subsidiaries; and (iv) does not have any other relationship with any directors, senior management, substantial shareholders or controlling shareholders of the Company.
