1. INTRODUCTION

United Overseas Bank Limited ("**UOB**") refers to the offer document issued by UOB, for and on behalf of NewMedCo Group Ltd. (the "<u>Offeror</u>") dated 21 March 2022 (the "<u>Offer Document</u>"), in relation to the voluntary unconditional cash offer (the "<u>Offer</u>") for all the issued and paid-up ordinary shares (the "<u>Shares</u>") in the capital of Singapore O&G Ltd. (the "<u>Company</u>"), other than any Shares held in treasury and those Shares held, directly or indirectly, by the Offeror as at the date of the Offer.

2. <u>DEALINGS</u>

3. LEVEL OF ACCEPTANCES

UOB wishes to announce, for and on behalf of the Offeror that:

- (a) Acceptances of the Offer. As at 6.00 p.m. (Singapore time) on 29 March 2022, based on information available to the Offeror, the Offeror has received valid acceptances amounting to 365,589,788 Shares, representing approximately 76.59% of the total number of issued Shares, which includes acceptances received from persons acting in concert with the Offeror, amounting in aggregate to 349,136,588 Shares, representing approximately 73.14% of the total number of issued Shares.
- (b) **Shares held on or before the Offer Announcement Date.** As at the Offer Announcement Date:
 - (i) the Offeror did not hold any Shares; and
 - (ii) the persons acting in concert with the Offeror collectively owned or controlled an aggregate of 356,818,112 Shares³, representing approximately 74.75% of the total number of issued Shares.
- (c) Shares acquired after the Offer Announcement Date and up to 6.00 p.m. (Singapore time) on 29 March 2022 (other than pursuant to valid acceptances of the Offer). Following the Offer Announcement Date and up to 6.00 p.m. (Singapore time) on 29 March 2022, save for the acquisition by the Offeror on the SGX-ST of an aggregate of 18,381,100 Shares, representing approximately 3.85% of the total number of issued Shares, the Offeror and persons acting in concert with it have not acquired or agreed to acquire any Shares (other than pursuant to valid acceptances of the Offer).
