## **ANNUAL GENERAL MEETING TO BE HELD ON 19 JUNE 2020**

- 1. <u>Background</u>: Parkway Trust Management Limited, the manager of Parkway Life Real Estate Investment Trust ("Parkway Life REIT", and as manager of Parkway Life REIT, the "Manager"), refers to:
  - (i) its announcement of 2 April 2020 stating that it had applied to and obtained the approval of Singapore Exchange Securities Trading Limited (the "SGX-ST") for an extension of time until 30 June 2020 for Parkway Life REIT to hold its annual general meeting in respect of the financial year ended 31 December 2019 ("AGM");
  - (ii) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed entities in Singapore to, inter alia, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means; and
  - (iii) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, inter alia, general meetings of real estate investment trusts.
- 2. <u>Date, time and conduct of AGM</u>: The Manager wishes to announce that pursuant to the Order, the AGM will be convened and held by way of electronic means, on Friday, 19 June 2020 at 9.00 a.m. (Singapore time).
  - The Manager's Chairman, Mr. Ho Kian Guan, and Executive Director and Chief Executive Officer, Mr. Yong Yean Chau, will conduct the proceedings of the AGM and Chief Financial Officer, Mr. Loo Hock Leong, will address substantial and relevant questions which holders of units in Parkway Life REIT ("**Units**" and the holders of Units, the "**Unitholders**") have submitted in advance.
- 3. Notice of AGM and proxy form: The Notice of AGM and proxy form will be sent to Unitholders solely by electronic means via publication on Parkway Life REIT's website at the URL <a href="http://plifereit.listedcompany.com/agm2020.html">http://plifereit.listedcompany.com/agm2020.html</a>, and will also be made available on the SGX website at the URL <a href="https://www.sgx.com/securities/company-announcements">https://www.sgx.com/securities/company-announcements</a>. Printed copies of these documents will <a href="notice">notice</a> sent to Unitholders.
- **4. No personal attendance at AGM:** Due to the current COVID-19 restriction orders in Singapore, **Unitholders will not be able to attend the AGM in person**.

- **5.** Alternative arrangements for participation at the AGM: Unitholders may participate at the AGM by:
  - (i) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
  - (ii) submitting questions in advance of the AGM; and
  - (iii) appointing the Chairman of the AGM as proxy to attend, speak and vote on their behalf at the AGM.

Alternative arrangements relating to attendance at the AGM via electronic means (including arrangements by which the meeting can be electronically accessed via live audio-visual webcast or live audio-only stream), submission of questions to the Chairman of the AGM in advance of the AGM, addressing of substantial and relevant questions at the AGM and voting by appointing the Chairman of the AGM as proxy at the AGM, are set out in the Notice of AGM.
