#### 13. Remarks (*if any*):

In the Initial Announcement dated 21 June 2021 (Announcement Reference: SG210622OTHR0AGP), it was disclosed that there is an increase in Mr Sandiaga Salahuddin Uno's (the "Substantial Shareholder") deemed interest in the shares of the Listed Issuer, arising from the acquisition of 10,225,000 shares of Seroja Investments Limited (the "Listed Issuer").

The Substantial Shareholder's deemed interest in the shares of the Listed Issuer had increased, arising from the acquisition of 1,000,000 shares of the Listed Issuer pursuant to a Sale and Purchase Agreement entered into on 3 July 2017 (the "First Transaction"). The date of becoming aware of the change in the Substantial Shareholder's deemed interest in the shares of the Listed Issuer as a result of the First Transaction should

therefore have been disclosed as 3 July 2017. Subsequently, the Substantial Shareholder's deemed interest in the shares of the Listed Issuer had further increased, arising from the acquisition of 9,225,000 shares of the Listed Issuer pursuant to a Sale and Purchase Agreement entered into on 9 July 2018 (the "Second Transaction"). The date of becoming aware of the change in the Substantial Shareholder's deemed interest in the shares of the Listed Issuer as a result of the Second Transaction should therefore have been disclosed as 9 July 2018.

The matters pertaining to the acquisition of the shares of the Listed Issuer in the First Transaction and the Second Transaction are both handled by the staff of the purchaser, Uno Capital Holdings, being Ms Tri Haryati, who is listed as the contact person for under Form C to the Form 3 providing notification to the Listed Issuer on 21 June 2021. The staff was under the erroneous belief that the Listed Issuer only needed to be informed of the change in the Substantial Shareholder's deemed interest when the shares are going to be transferred from the vendor to the purchaser. These shares were not transferred after the sale and purchase agreements were signed. Sometime on or about 21 June 2021, Ms. Tri Haryati was informed by the vendors that the shares have not been transferred and that they were going to transfer the shares to the purchaser. Ms. Trie then informed the Listed issuer on 21 June 2021 that Uno Capital had purchased the said shares.

The present notification is a replacement filed to correct the inaccurate disclosure of the Initial Announcement dated 22 June 2021.
