Frasers Property Limited ("FPL") holds a 100% direct interest in each of FCAM and Frasers Property Retail Trust Holdings Pte. Ltd. ("FPRTH"). FCAM and FPRTH hold units in FCT ("Units"). FPL therefore has a deemed interest in the Units in which each of FCAM and FPRTH has an interest, by virtue of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore ("SFA").

MMC together with Risen Mark Enterprise Ltd. and Golden Capital (Singapore) Limited collectively holds a greater than 20% interest in Thai Beverage Public Company Limited ("ThaiBev");

- ThaiBev holds a 100% direct interest in International Beverage Holdings Limited ("IBHL");
- IBHL holds a 100% direct interest in InterBev Investment Limited ("IBIL");
- IBIL holds a greater than 20% interest in FPL;
- FPL holds a 100% direct interest in each of FCAM and FPRTH; and
- FCAM and FPRTH hold units in FCT.

MMC therefore has a deemed interest in the units in FCT in which FPL has an interest, by virtue of Section 4 of the SFA.

FCT is a real estate investment trust. The manager of FCT is FCAM (the "REIT Manager").

The REIT Manager had, on 9 October 2020, launched a non-renounceable preferential offering of 324,639,666 new Units ("New Units") on the basis of 290 New Units for every 1,000 existing Units (fractions of a New Unit to be disregarded) held as at 5.00 p.m. on Tuesday, 6 October 2020 (the "Preferential Offering"). Under the Preferential Offering, 188,870,419 New Units were issued to FPRTH and FCAM. MMC is therefore deemed interested in an aggregate of 687,790,767 Units.

The percentage of unitholdings "immediately before the transaction" is based on 1,364,128,127 Units in issue as at 26 October 2020.

The percentage of unitholdings "immediately after the transaction" is based on 1,688,767,793 Units in issue as at 27 October 2020.
