Dr. Ou specializes in TCM and Acupuncture treatment for Gynaecological diseases, in particular male and female infertility, postpartum conditioning, women's irregular menstruation and Gynaecological

tumors etc. She has also accumulated intensive experience on female postpartum treatment by herbs food and therapy.

Dr. Ou graduated from Guangzhou University of TCM and worked as a TCM Physician at the Rongqi Hospital (Guangdong China) before relocating to Singapore. In 2009 she received her Ph.D. in TCM from Nanjing University of TCM. Dr. Ou had been a lecturer and clinical tutor at the Singapore College of Traditional Chinese Medicine from 2004 to 2015. She is a member of Gynaecology Research Group at the Singapore Academy of Chinese Medicine, and member of the Singapore Chinese Association. She also acts as an Appointed Examiner for Singapore Traditional Chinese Medicine Physicians Registration Examination (TCMPB, MOH) since 2014.
