
The Cairns Pte. Ltd. ("Cairns") holds more than 50 per cent. of the voting rights of The Straits Trading Company Limited ("STC").

By virtue of the foregoing, Cairns has a deemed interest in the units of Suntec Real Estate Investment Trust ("Units") in which each of SRE and Sword has a direct interest in.

In addition, STC, through its wholly-owned subsidiaries, Straits Equities Holding (One) Pte. Ltd. ("SEH One") and Straits Equities Holding (Two) Pte. Ltd. ("SEH Two"), collectively holds not less than 20 per cent. of the voting rights in ARA Asset Management Limited ("ARA"). ARA in turn holds more than 50 per cent. of the voting rights of each of ARA Trust Management (Suntec) Limited ("ARA Suntec") and ARA Investors II Limited ("ARA Investors II"). By virtue of the foregoing, Cairns has a deemed interest in the Units in which each of ARA Suntec and ARA Investors II has a direct interest in.
