**WHAT WOULD YOU GAIN OR LOSE IN DIFFERENT SITUATIONS?**

- **Best case scenario:**  
The index level of the Index decreases substantially resulting in a significant increase in the price of the Warrants. You would then sell the Warrants and realise a profit.
