Following completion of the cancellation of Jardine Strategic’s 59% shareholding in JMH on 18 May 2022 and implementation of the Scrip Dividend Scheme, JMH was notified on 24 May 2022 by 1947 Trustee Limited, in its capacity as the trustee of a trust created in 1947, that its interest in JMH had increased from 5.01% to 12.41% of the voting rights.
