We, Principal Asset Management (S) Pte. Ltd. (the "**Manager**"), the manager of the Fund, wish to inform you of the following changes that were made to the Fund:

(1) Changes to the directors of the Manager;

Ms Chong Chooi Wan was appointed as a director of the Manager on 12 June 2020. Ms Chong replaces Ms Lum Joy Deng, who resigned as a director of the Manager on 15 June 2020.

(2) <u>Creations and redemptions in cash only;</u>

With effect from 18 September 2020, the Manager has ceased to permit partial delivery / in-kind settlement (by delivery of Index Securities) ("In-Kind Settlement") for creations and redemptions of units in the Fund ("Units"). As such, with effect from 18 September 2020, the participating dealers for the Fund may only create and redeem Units using cash.


In view that In-Kind Settlement is no longer available, with effect from 18 September 2020, the Manager has ceased to charge the partial delivery request fee and the transaction fees for full or partial securities settlements.

(3) Removal of extended settlement; and

In view that In-Kind Settlement is no longer available, with effect from 18 September 2020, extension of the settlement period is longer permitted and the Manager has accordingly ceased to charge the extension fee.

(4) <u>Change in minimum initial and subsequent subscription amounts, application/creation size and minimum redemption amount.</u>
With effect from 18 September 2020, these have been reduced from 50,000 Units to 10,000 Units.

The above changes are reflected in the amended prospectus for the Fund that was registered by the Monetary Authority of Singapore on 18 September 2020 and the Fifth Amending and Restating Deed of the Fund dated 18 September 2020.
