Sumitomo Mitsui Trust Holdings, Inc. ("SMTH") has a deemed interest in Frasers units, on the basis of its controlling interest in each of Sumitomo Mitsui Trust Asset Management Co., Ltd. ("SMTAM") and Sumitomo Mitsui Trust Bank, Limited ("SMTB"). SMTB in turn has a controlling interest in Nikko Asset Management Co., Ltd. ("NAM") which has a controlling interest in Nikko Asset Management International Limited ("NAMIL"). NAMIL has a controlling interest in Nikko Asset Management Asia Limited ("NAMAsia") and separately holds more than 20% of the shareholdings of Affin Hwang Asset Management Berhad ("AHAM"). AHAM has a controlling interest in AIIAMAN Asset Management ("AIIAMAN").

Therefore, SMTH is deemed to have an interest in Frasers units held in aggregate by portfolios managed by SMTB, SMTAM, NAM, NAMAsia, AHAM and AIIAMAN.
