AWARD OF S\$4.465 MILLION SITE INVESTIGATION CONTRACT

The Board of Directors (“**Directors**”) of Trittech Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that its wholly-owned subsidiary, Trittech Engineering & Testing (Singapore) Pte Ltd (“**Trittech Engineering**”), had on 4 February 2014, been awarded a S\$4.465 million contract, “Contract ER446 Site Investigation Works for LTA Projects” (the “**Contract**”) by the Land Transport Authority (“**LTA**”).

Trittech Engineering has been appointed by the LTA under the Contract to carry out site investigation works on any terrain in Singapore, including but not limited to the provision of all professional and technical personnel, labour, materials, plant and everything necessary for the proper execution of the services, and the supply of all necessary, shoring, platform, geotechnical investigation and construction equipment, plant and tools required for the services, properly maintained for use and removed on completion of the services.

The commencement date of the Contract is 4 February 2014 and the expected completion date is 3 February 2017. There is no defects liability period.

Save for the Company’s independent director, Professor Yong Kwet Yew, who is a board and executive committee member of the LTA, none of the Directors or substantial shareholders of the Company has any interest, direct or indirect, in the Contract (other than through their shareholdings in the Company). Professor Yong Kwet Yew was not involved in giving any recommendation in respect of the Contract or in any discussions or negotiations leading to the award of the Contract.

The Contract is not expected to have any material impact on the consolidated earnings per share and/or net tangible assets per share of the Group for the current financial year ending 31 March 2014.
