Dear Sir,

Merujuk pada Keterbukaan Informasi kami tertanggal 29 Nopember 2017 tentang Putusan Pengadilan Negeri Jakarta Barat No. 01/Pdt.Sus-KPPU/2017/PN.Jkt.Br. tertanggal 29 November 2017 yang membatalkan Putusan Komisi Pengawas Persaingan Usaha ("KPPU") pada Perkara Nomor 02/KPPU-I/2016, atas dugaan pelanggaran pasal 11 (ketentuan mengenai kartel) Undang-Undang No. 5 tahun 1999 tentang Larangan Praktek Monopoli dan Persaingan Usaha Tidak Sehat terhadap Perseroan dan pelaku usaha lainnya.

We refer to our Disclosure of Information dated November 29, 2017 regarding West Jakarta District Court Decision No. 01/Pdt.Sus-KPPU/2017/PN.Jkt.Br. dated November 29, 2017 rejecting the Decision of the Commission for the Supervision of Business Competition ("KPPU") on Case Number 02/KPPU-I/2016, in respect of the allegation of violation of article 11 (law relating to cartel) of Law No. 5/1999 on Prohibition of Monopolistic Practices and Unfair Business Competition by the Company and other companies.

Kami informasikan bahwa pada tanggal 12 September 2018, Perseroan telah menerima Putusan Mahkamah Agung No. 444 K/Pdt.Sus-KPPU/2018 tanggal 15 Mei 2018, yang membatalkan kasasi KPPU terhadap Putusan Pengadilan Negeri Jakarta Barat tersebut.

We hereby inform that on 12 September 2018, the Company has received Supreme Court decision No. 444 K/Pdt.Sus-KPPU/2018 dated May 15, 2018, rejecting KPPU's appeal against the said West Jakarta District Court Decision.

Pembatalan Putusan tersebut berarti Putusan Pengadilan Negeri Jakarta Barat sah, mengikat dan telah memiliki kekuatan hukum yang tetap. Putusan Pengadilan Negeri Jakarta Barat ini mengadili dan memutuskan antara lain:

The said rejection means that the Decision of the West Jakarta District Court is valid, binding and has a permanent legal force. The West Jakarta District Court Decision adjudicated and decided, among others:

1. Menerima permohonan keberatan dari 11 perusahaan yang mengajukan keberatan termasuk Perseroan;
2. Membatalkan putusan KPPU Nomor 02/KPPU-I/2016 tertanggal 13 Oktober 2016; dan
3. Menyatakan seluruh pemohon keberatan tidak terbukti melanggar pasal 11 (ketentuan mengenai kartel) dari Undang-Undang No. 5/ tahun 1999 tentang Larangan Praktek Monopoli dan Persaingan Usaha Tidak Sehat (Undang-undang anti Monopoli).

1. Accepted the appeal of 11 appellants (companies) including the Company;
2. Revoked the KPPU's Decision Number 02/KPPU-I/2016 dated 13 October 2016; and
3. Declared that all appellants were not proven to be in violation of article 11 (law relating to cartel) of Law No. 5/1999 on the Prohibition of Monopolistic Practices and Unfair Business Competition (anti-trust law).
