The deemed interests above arose from Lum Chang Investments Pte Ltd ("LCI") and RMDV. Mr. Raymond Lum is deemed to have interests in the whole of LCI and RMDV's shareholdings in LCH by virtue of his interests of not less than 20% in the issued share capital of LCI and RMDV. In addition, Mr. Raymond Lum is also a director of LCI and RMDV.

The change in the interests is due to an acquisition of 137,559,212 LCH ordinary shares by RMDV as mentioned at Section 12 below and Mr. Lum's direct interests of 15,528,397 before the transaction which is now held through a nominee account.

On 17 November 2020, United Overseas Bank Limited, for and on behalf of RMDV Investments Pte Ltd (the "Offeror"), made a mandatory cash offer (the "Offer") to acquire all of the issued ordinary shares ("Shares")(excluding treasury shares) in the capital of LCH other than those Shares already owned, controlled or agreed to be acquired by the Offeror and parties acting in concert with it.

(1) The Offeror made market and off-market acquisitions aggregating 41,213,200 Shares, representing approximately 10.94% of the total number of issued Shares, during the period of the Offer up to the close of the Offer at 5.30p.m. on 18 January 2021 (the "Close of Offer").

(2) The Offeror received valid acceptances tendered pursuant to the Offer up to the Close of Offer aggregating 96,346,012 Shares, representing approximately 25.58% of the total number of issued Shares.

(3) The percentages of shareholding interests are calculated based on the total of 376,688,104 Shares (excluding 8,341,500 treasury shares).
