PT Alpha Sentra Prima ("**PT Alpha**") and OUE Beta Pte. Ltd. ("**OUE Beta**") have acquired ordinary shares representing approximately 98% and approximately 2% of the total number of issued ordinary shares (of par value IDR 10,000,000 (approximately S\$1,000)) in each of the following companies respectively for the aggregate consideration as follows:

PT Alpha and OUE Beta are indirect wholly-owned subsidiaries of the Company.

Following the Acquisition and Subscription, each of PT Kencana, PT Mega, PT Mitra, PT Agra, PT Pelangi, PT Panca, PT Bangun, PT Lestari and PT Bukit has become an indirect wholly-owned subsidiary of the Company. Each of PT Kencana, PT Mega, PT Mitra, PT Agra, PT Pelangi, PT Panca, PT Bangun, PT Lestari and PT Bukit is an investment holding company and is currently dormant.

The Acquisition and Subscription are not expected to have a material effect on the net tangible assets or earnings per share of the Group for the financial year ending 31 December 2017.

None of the Directors of the Company has any interest, direct or indirect, in the Acquisition.
