**CONDUCT OF ANNUAL GENERAL MEETING ON WEDNESDAY, 27 APRIL 2022 BY ELECTRONIC MEANS**

---

The Board of Directors of Multi-Chem Limited (the “**Company**”) refers to:

- (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, inter alia, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
- (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the “Order”) which sets out the alternative arrangements in respect of, inter alia, general meetings of companies; and
- (c) the joint statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation of 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020, 1 October 2020 and 27 December 2021) which provides guidance on the conduct of general meetings amid the evolving COVID-19 situation beyond 30 June 2021.

In light of the above developments and the evolving COVID-19 situation, the Company will be convening the Annual General Meeting (the “**AGM**”) by electronic means on Wednesday, 27 April 2022 at 11.30 a.m. with the following additional measures for participation at the AGM:

**1. Conduct of AGM**

- 1.1 The Company's AGM for FY2021 will be held by electronic means on Wednesday, 27 April 2022 at 11.30 a.m..
- 1.2 Shareholders will not be able to attend the AGM in person.
- 1.3 Alternative arrangements for participation at the AGM are in place for shareholders to participate at the AGM by:
  - (a) observing and/or listening to the proceedings of the AGM through either live audio-visual webcast or live audio-only stream (“**electronic means**”);
  - (b) submitting questions in advance of the AGM;
  - (c) appointing the Chairman of the AGM as proxy to vote on their behalf at the AGM.

**2. Pre-Registration for live webcast or live audio-only stream**

- 2.1 Shareholders can register by 11.30 a.m. on 24 April 2022 via the pre-registration form at <http://www.multichem.com.sg/html/registration.php>. Upon verification, the Company will provide authenticated Shareholders with:
  - (a) confirmation email by 25 April 2022 with access link and the password details to watch the live webcast of the AGM proceedings;
  - (b) notification of telephone number by 25 April 2022 for dial-in for observation of the AGM proceedings.
- 2.2 Shareholders must not forward the abovementioned link or telephone number to other persons who are not shareholders of the Company and who are not entitled to attend the AGM. This is also to avoid any technical disruptions or overload to the live webcast.

- 2.3 Shareholders, who would have been able to be appointed as proxies by relevant intermediaries under Section 181(1C) of the Companies Act 1967 of Singapore, such as SRS investors, should approach their SRS Operators to participate in the AGM via electronic means.
- 2.4 Should shareholders who have registered by 11.30 a.m. on 24 April 2022 but have not received email by 11.30 a.m. on 26 April 2022, please email to [finance@multichem.com.sg](mailto:finance@multichem.com.sg).

**3. Submit Questions in Advance**

- 3.1 Shareholders will not be able to ask questions during the AGM via electronic means, and therefore it is important for Shareholders to submit their questions in advance of the AGM.
- 3.2 Shareholders may submit any questions related to the resolutions to be tabled for approval at the AGM and the Company will endeavour to address the substantial questions during the AGM proceedings.
- 3.3 Please submit questions in advance related to the Agenda in the Notice of AGM before 5.30 p.m. on 18 April 2022 via the pre-registration form at <http://www.multichem.com.sg/html/registration.php>. The Company will endeavour to address the substantial and relevant questions from shareholders on the SGXNET before 11.30 am on 21 April 2022. Any subsequent questions related to AGM Agenda received after 5.30 p.m. on 18 April 2022 will be addressed during the AGM on 27 April 2022, of which the AGM will be held by electronic means. The minutes of the AGM will be published on SGXNET within one (1) month after the conclusion of the AGM.
- 3.4 Shareholders, who would have been able to be appointed as proxies by relevant intermediaries under Section 181(1C) of the Companies Act 1967 of Singapore, such as SRS investors, should approach their SRS Operators, to submit their questions in relation to any resolution set out in the Notice of AGM prior to the AGM and have their substantial queries and relevant comments answered.

**4. Proxy Voting**

- 4.1 Shareholders who wish to exercise their voting rights at the AGM may do so via proxy voting appointing Chairman of the AGM. Shareholders would have to submit the Proxy Form appointing Chairman of the AGM as their Proxy ("**Proxy Form**"). Please note that Shareholders will not be able to vote through the live webcast or live audio-only stream and can only vote with their proxy forms which are required to be submitted as set out below.
- 4.2 Shareholders may submit the Proxy Form by 11.30 a.m. on 24 April 2022 as follows:
  - (a) deposit the signed hard copy Proxy Form at the registered office of the Company at 18 Boon Lay Way #05-113, Tradehub 21, Singapore 609966; or
  - (b) send electronic mail to [finance@multichem.com.sg](mailto:finance@multichem.com.sg) enclosing signed PDF copy of the Proxy Form.
- 4.3 SRS investors who wish to appoint the Chairman of the AGM to act as their proxy should approach their SRS Operators to submit their votes to the Company (a) by email, be received by the Company at [finance@multichem.com.sg](mailto:finance@multichem.com.sg); or (b) by post, be lodged at the registered office of the Company at 18 Boon Lay Way #05-113, Tradehub 21, Singapore 609966, at least seven (7) working days before the AGM (i.e. by 11.30 a.m. on 18 April 2022).
- 4.4 In view of the current COVID-19 situation and the related safe distancing measures which may make it difficult for Shareholders to submit completed Proxy Forms by post, shareholders are strongly encouraged to submit completed Proxy Forms electronically via email as early as possible, to enable your vote(s) to be counted, and to follow all government guidance and requirements.

Shareholders are reminded not to congregate to watch the live webcast and ensure that safe distancing measures are practiced and regulations and all government advisories are adhered to.

As the Covid-19 situation continues to evolve, the Company will closely monitor the situation and reserves the right to take such precautionary measures as may be appropriate at the AGM, including any precautionary measures as may be required or recommended by government agencies or the SGX Regco from time to time, in order to minimise the risk of community spread of Covid-19. The Company may also be required to change its AGM arrangements at short notice.
