**AGM Timeline**") has been submitted to the SGX-ST on 3 August 2020.

Reference is being made to the announcement of the Company dated 29 April 2020, 7 May 2020 and 19 May 2020 ("**Previous Announcements**") and unless otherwise defined, capitalised terms in this announcement shall have the same meanings as ascribed to them in the Previous Announcement.

The 2<sup>nd</sup> FY2020 Q1 EOT is sought for mainly due to unexpected delay in finalizing the signing-off of audited FY2019 consolidated financial statements. Accordingly, the 1QFY2020 Results Announcement is currently expected to be released by 13 August 2020 instead of 3 August 2020.

In view of the above, the FY2019 AGM is targeted to be convened by 27 August 2020 instead of 25 August 2020. 2QFY2020 Results Announcement will be released on the SGXNet by 14 August 2020 following the release of 1QFY2020 Results Announcement.
