

ALLOTMENT AND ISSUANCE OF SHARES PURSUANT TO WARRANT EXERCISE

The Board of Directors (the "**Board**") of ValueMax Group Limited (the "**Company**") wishes to announce the number of issued ordinary shares of the Company has increased from 867,994,957 ordinary shares (inclusive of 100,000 treasury shares) to 868,090,559 ordinary shares by way of allotment and issuance 195,602 warrants at the exercise price of S\$0.36 each, on 7 May 2024.
