## **CEO Appointment at Keppel REIT Management**

His familiarity with Keppel REIT and its business operations, coupled with his expertise and in-depth knowledge of the real estate sector, will put the REIT in good stead to seize further opportunities for growth.

Beyond his role in Keppel Land, Mr Tan is the First Vice President of the Singapore Green Building Council and a Member of the World Green Building Council's Corporate Advisory Board. In addition, he serves as Honorary Secretary on the Management Council of Real Estate Developers' Association of Singapore and the Workplace Safety Health Council (Construction and Landscape Committee).

Mr Tan holds a Bachelor of Science (First Class Honours) in Estate Management from the National University of Singapore, and a Master of Business Administration in Accountancy from the Nanyang Technological University.
