Further to the Announcements, the Board wishes to announce that the Company had, on 18 August 2020, allotted and issued 8,928,570 Adjusted Conversion Shares to certain Subscribers at the Adjusted Conversion Price of S\$0.14, following conversion of the Convertible Bonds with an aggregate principal amount of S\$1,250,000, in accordance with the Terms and Conditions.

The Adjusted Conversion Shares will rank *pari passu* in all respects with the existing issued shares in the capital of the Company, save for any dividends, rights, allotments or other distributions the record date for which precedes the date of issue of the Adjusted Conversion Shares.

Following the allotment and issuance of the Adjusted Conversion Shares, the issued and paid-up share capital of the Company has increased from 600,269,942 Shares to 609,198,512 Shares.

The Adjusted Conversion Shares will be listed and quoted on the Catalist Board of the Singapore Exchange Securities Trading Limited and trading of the Adjusted Conversion Shares will commence from 9.00 a.m. on or about 20 August 2020.
