2,769,113 Stapled Securities had been issued to the REIT Manager as payment of the REIT Manager's management fees on 13 August 2015 (the "13 August Issuance"). As a result of the 13 August Issuance, the REIT Manager has a direct interest in 23,409,826 Stapled Securities (the "RM Stapled Securities").

The REIT Manager is a wholly-owned subsidiary of OUE Limited ("OUE"). Accordingly, OUE has a deemed interest in the RM Stapled Securities and a direct interest in 440,432,631 Stapled Securities, amounting to a total interest in 463,842,457 Stapled Securities (the "OUE Stapled Securities").

OUE Realty Pte. Ltd. ("OUE Realty") is the holding company of OUE. Accordingly, OUE Realty has a deemed interest in the OUE Stapled Securities and a direct interest in 83,752,176 Stapled Securities, amounting to a total interest in 547,594,633 Stapled Securities.
