Tan Sri Cheng Heng Jem ("Tan Sri") is deemed to be interested in 14,093,000 ordinary shares comprising 13,960,000 ordinary shares deemed held by Lion Corporation Berhad ("LCB"), 100,000 ordinary shares held by Lion AMB Resources Berhad and 33,000 ordinary shares held by Lion Industries Corporation Berhad.

LCB is deemed to be interested in 13,960,000 ordinary shares deemed held by ACB Resources Berhad ("ACB").

ACB is deemed to be interested in 13,960,000 ordinary shares comprising 5,583,000 ordinary shares beneficially held by The Brooklands Selangor Rubber Company Limited, 5,102,000 ordinary shares deemed held by Angkasa Marketing (Singapore) Pte Ltd ("Angkasa") and 3,275,000 ordinary shares held by Umatrac Enterprises Sdn Bhd.
