Up to 720 ITE students to benefit from programme that will provide on-the-job training and work experience

Singapore, 28 April, 2016 – mm2 Asia Ltd. "We would like to enhance this foundation by giving them the practical industry experience in content creation through our extensive network. With the growing demand for talents in the region for content creation, especially in North Asia, we hope more of our talents will have opportunities to excel beyond Singapore."
