TOTM Technologies secures US\$4.9 million biometric project to provide biometric solutions to a law enforcement agency in Indonesia

- **To provide biometric identification and surveillance systems to boost law enforcement capability, efficiency and security**
- **The project is expected to be completed in 2022**
- **Opportunity to further enhance our portfolio with government agencies to provide identity management biometric solutions**

SINGAPORE, 2 September 2022 – TOTM Technologies Limited. (“**TOTM Technologies**” or the “**Company**” and, together with its subsidiaries, the “**Group**”) is pleased to announce that the Group has secured a project with an aggregate value of US\$4.9 million (equivalent to S\$6.8 million¹) to supply biometric identification and surveillance systems to one of the law enforcement agencies in Indonesia.

The project involves the implementation of a facial recognition and surveillance system for facility access management and control to increase security. For this purpose, the Group will source and procure the required hardware and software and integrate the subsystems into a comprehensive solution for the end customer. The project is expected to be completed by the end of 2022 and will contribute positively to the Group’s FY2023 performance.

Mr Pierre Prunier, CEO and Executive Director of TOTM Technologies, said, “**We are pleased to be awarded the project. This contract win is a major milestone for us as it serves as a testament to our capability in delivering high quality solutions and excellent customer service in Indonesia. This will further strengthen our relationship with various government agencies in Indonesia and set the stage for more implementation of our identity management biometric solutions going forward. I would like to acknowledge the effort of our commercial team of our subsidiary InterBio (PT. International Biometrics Indonesia) who has played a fundamental role in forging ahead in the Indonesian market.**”

The Ministry of National Development Planning of Indonesia has identified digital transformation as a key pillar that the government must focus on in 2021 to ensure effective public service and governance². Identity management solutions tapping on the National ID database will be able to increase efficiency and productivity and reform public service delivery so that government e-services can be accessed by citizens safely, anytime and anywhere. This augurs well for the Group as it has a proven track record in the deployment and maintenance of the biometric National ID system in Indonesia, which currently has over 200 million of enrolled citizens.

“With foundational infrastructure like the National ID database already in place, it will be easier to roll out functional applications with identity management biometric technology solutions to other government agencies as well as private sectors more quickly. There’s definitely a lot more that we can do for the Indonesian government in
