

# Keppel Pacific Oak US REIT

(Constituted in the Republic of Singapore pursuant to a trust deed dated 22 September 2017 (as amended))

## ANNUAL GENERAL MEETING OF KEPPEL PACIFIC OAK US REIT TO BE HELD ON 20 APRIL 2022

1. **Background:** Keppel Pacific Oak US REIT Management Pte. Ltd., as manager of Keppel Pacific Oak US REIT (the "**Manager**"), refers to:
  - (a) the Notice of Annual General Meeting dated 29 March 2022 ("**Notice of AGM**"), which is published on Keppel Pacific Oak US REIT's website at <https://www.koreusreit.com/investor-relations/agm-egm/> and on SGXNet;
  - (b) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for the conduct of general meetings, either wholly or partly, by electronic communication, video conferencing, teleconferencing or other electronic means; and
  - (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "**Order**") which was gazetted on 13 April 2020, and the Joint Statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore, and Singapore Exchange Regulation titled "Guidance on the Conduct of General Meetings Amid Evolving COVID19 Situation" issued on 4 February 2022, which set out the alternative arrangements in respect of, *inter alia*, general meetings of real estate investment trusts.
2. **Date, time and conduct of Annual General Meeting:** The Manager wishes to announce that pursuant to the Order, the Annual General Meeting of Keppel Pacific Oak US REIT ("**AGM**") will be convened and held by way of electronic means on **Wednesday, 20 April 2022 at 10.30 a.m. (Singapore Time)**.
3. **Notice of AGM, proxy form and related documents:** Printed copies of the Notice of AGM and the proxy form will be sent to unitholders of Keppel Pacific Oak US REIT ("**Unitholders**").

In line with Keppel Pacific Oak US REIT's drive towards sustainable development, the annual report for the financial year ended 31 December 2021 ("**Annual Report 2021**") has been issued by the Manager and Unitholders may view and download the digital version of the Annual Report 2021, the Notice of AGM, appendix to the Notice of AGM ("**Appendix**") and the Proxy Form through this website link: <https://www.koreusreit.com/investor-relations/agm-egm/>.

- To access the Annual Report 2021, click on "Quick Downloads" under the Investor Relations tab and click on the relevant link to download.
- To access the Notice of AGM, Appendix and the Proxy Form, click on 'AGM & EGM Information' under the Investor Relations tab and click on the relevant link to download.

A Unitholder who still wishes to receive printed copies of the Annual Report 2021 and the Appendix for this year may complete the request form enclosed with the letter to Unitholders and return it to the Manager no later than 5.00 p.m. on 8 April 2022. All previous requests, including any standing instructions for printed annual reports, will be disregarded.

4. **No personal attendance at the AGM:** A Unitholder will **not** be able to attend the AGM in person.
5. **Participation in the AGM electronically:** Unitholders may participate in the AGM electronically by:
  - (a) observing and/or listening to the AGM proceedings via "live" audio-and-visual webcast on their mobile phones, tablets or computers or "live" audio-only stream on the telephone by pre-registering at <https://www.koreusreit.com/agm2022> no later than 10.30 a.m. on 18 April 2022;
  - (b) submitting questions in advance of and/or via the "live" textbox function at the AGM; and

- (c) voting at the AGM (i) by themselves or by the appointment of a proxy (other than the Chairman of the AGM (“Chairman”)) “live” via electronic means; or (ii) by the appointment of the Chairman as proxy to vote on their behalf. A proxy need not be a Unitholder. If a Unitholder wishes to vote, or appoint a proxy (other than the Chairman) to vote, “live” via electronic means at the AGM, such Unitholder must pre-register themselves or such proxy (as the case may be) at <https://www.koreusreit.com/agm2022>, and submit a proxy form if such Unitholder wishes to appoint a proxy, by no later than 10.30 a.m. on 18 April 2022.

Details on AGM matters relating to, among others, pre-registration, participating in the AGM, submission of questions in advance, asking questions via the "live" textbox function during the AGM and voting are set out in the Annex to this announcement.

**6. Persons who hold Units through relevant intermediaries:**

- (a) Persons holding units in Keppel Pacific Oak US REIT (“Units”) through Central Provident Fund (“CPF”) and Supplementary Retirement Scheme (“SRS”) (“CPF/SRS investors”) who wish to participate in the AGM by (i) observing and/or listening to the AGM proceedings via “live” audio-and-visual webcast or “live” audio-only stream; (ii) submitting questions in advance of or at the AGM; and/or (iii) exercising their votes at the AGM should follow the steps as set out in the Annex.
- (b) Persons holding Units through relevant intermediaries (other than CPF/SRS investors) who wish to participate in the AGM, **should contact the relevant intermediary through which they hold such Units as soon as possible, and by no later than 5.00 p.m. on 8 April 2022, in order to make the necessary arrangements for them to participate in the AGM and specify their voting instructions.**

A “relevant intermediary” means:

- (i) a banking corporation licensed under the Banking Act 1970 of Singapore, or a wholly-owned subsidiary of such a banking corporation, whose business includes the provision of nominee services and who holds Units in that capacity;
- (ii) a person holding a capital markets services licence to provide custodial services for securities under the Securities and Futures Act 2001 of Singapore, and who holds Units in that capacity; or
- (iii) the Central Provident Fund Board (“CPF Board”) established by the Central Provident Fund Act 1953 of Singapore, in respect of Units purchased under the subsidiary legislation made under that Act providing for the making of investments from the contributions and interest standing to the credit of members of the Central Provident Fund, if the CPF Board holds those Units in the capacity of an intermediary pursuant to or in accordance with that subsidiary legislation.

## ANNEX

Unitholders and CPF/SRS investors will be able to observe and/or listen to the AGM proceedings via “live” audio-and-visual webcast or “live” audio-only stream by pre-registering, submitting questions in advance of and/or asking questions via the “live” textbox function during the AGM, and voting “live” or, in the case of Unitholders only, by appointing a proxy to attend, speak and vote on their behalf at the AGM.

A Unitholder who wishes to submit a proxy form must complete and sign the proxy form, before submitting it by post to the address provided above, or before scanning and sending it by email to the email address provided above. The proxy form is not valid for use by Investors (including CPF/SRS investors) and shall be ineffective for all intents and purposes if used or purported to be used by them.

**Unitholders are strongly encouraged to submit completed proxy forms electronically via email.**

**Specific voting instructions to be given:** Where Unitholders (whether individual or corporate) appoint the Chairman as their proxy, they must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the proxy form, failing which the appointment of the Chairman as proxy for that resolution will be treated as invalid.

Where a Unitholder (whether individual or corporate) appoints a proxy (other than the Chairman) to be his/her/its proxy through the proxy form to vote "live" via electronic means at the AGM but does not pre-register such proxy at **<https://www.koreusreit.com/agm2022>** by 10.30 a.m. on 18 April 2022, (a) if specific instructions as to voting, or abstentions from voting, in respect of a resolution in such proxy form are given, the Chairman will be appointed as the proxy to vote in accordance with such instructions, or (b) if specific instructions are not given as to voting, or abstentions from voting, in respect of a resolution in such proxy form, the appointment of such proxy (other than the Chairman) as proxy for that resolution will be treated as invalid.
