In connection with the restructuring exercise whereby the ordinary voting shares in Admiralty were replaced with non-voting participatory shares in Admiralty, ASML was issued with one management share in the capital of Admiralty, representing 100% of the voting shares in the capital of Admiralty.

As a result, while AARMF ceased to hold any voting shares in Admiralty and accordingly ceased to have a deemed interest in the 618,916,410 Shares in which Admiralty has an interest, ASML continues to have a deemed interest in the 618,916,410 Shares in which Admiralty has an interest by reason of its controlling interest in Admiralty.
