ANNOUNCEMENT – RECEIPT OF APPROVAL IN-PRINCIPLE FROM THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED FOR THE PROPOSED RENOUNCEABLE NON-UNDERWRITTEN RIGHTS ISSUE

Singapore, 6 November 2014. Tiger Airways Holdings Limited (the “**Company**” or “**Tiger Airways**”) refers to the announcement dated 17 October 2014 (the “**Announcement**”) made by the Company in connection with its proposed renounceable non-underwritten rights issue (the “**Rights Issue**”) of up to 1,169,842,389¹ new ordinary shares in the capital of the Company (the “**Rights Shares**”) at an issue price of S\$0.20 for each Rights Share on the basis of 85 Rights Shares for every 100 existing ordinary shares in the capital of the Company (the “**Shares**”) held by shareholders of the Company (the “**Shareholders**”) as at a date and time to be determined by the directors of the Company for the purpose of determining the Shareholders’ entitlements under the Rights Issue (the “**Record Date**”), fractional entitlements to be disregarded.

The Company wishes to announce that it had on 5 November 2014 received the approval in-principle of the Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) for the dealing in, listing of and quotation for the Rights Shares on the Main Board of the SGX-ST, subject to the following conditions:

- (a) compliance with the SGX-ST’s listing requirements;
- (b) Shareholders’ approval for the Rights Issue;
- (c) a written undertaking from the Company that it will comply with Rules 704(30), 815 and 1207(20) of the SGX-ST Listing Manual in relation to the use of the proceeds from the Rights Issue and where proceeds are to be used for working capital purposes, the Company will disclose a breakdown with specific details on the use of proceeds for working capital in the Company’s announcements on the use of proceeds and in the annual report;

¹ Assuming that (i) all the share options that have been granted by the Company under the Pre-IPO Tiger Aviation Share Option Scheme which are exercisable are exercised prior to the Record Date and (ii) all holders of the Convertible Securities exercise their conversion rights based on the Adjusted Conversion Price prior to the Record Date such that the Conversion Shares will rank for the Rights Issue.

(d) a written undertaking from the Company that it will comply with the confirmation given in Rule 877(10) of the SGX-ST Listing Manual with regards to the allotment of any excess Rights Shares; and

(e) a written confirmation from financial institution(s) as required under Rule 877(9) of the SGX-ST Listing Manual that the substantial shareholder who has given the irrevocable undertaking has sufficient financial resources to fulfil its obligations under its undertaking.

The approval in-principle granted by the SGX- ST for the dealing in, listing of and quotation for the Rights Shares is not to be taken as an indication of the merits of the Rights Issue, the Rights Shares, the Rights, the Company and/or its subsidiaries.

A circular to Shareholders containing, *inter alia*, details of the Rights Issue, together with the notice of the extraordinary general meeting to be convened, will be despatched to Shareholders in due course.
