CapitaLand Limited ("CapitaLand") wishes to announce that its wholly owned subsidiaries, C31 Ventures Fund 1 Pte. Ltd. ("C31VF1") and C31VF1-001V Pte. Ltd. ("001V"), have increased their respective issued and paid-up share capital by way of an allotment of additional redeemable preference shares ("RPS") (the "Shares Increase") for cash consideration to their existing shareholders, as follows:

The proceeds of the equity injection will be used to fund the general working capital requirements and investment activities of C31VF1 and 001V, respectively.

Following the Shares Increase,

- (a) C31VF1's issued and paid-up share capital is S\$4,082,001 comprising one ordinary share and 4,082,000 RPS; and
- (b) 001V's issued and paid-up share capital is \$\$1,306,997 comprising one ordinary share and 1,306,996 RPS.

C31VF1 and 001V remain wholly owned subsidiaries of CapitaLand.

The above is not expected to have any material impact on the net tangible assets or earnings per share of the CapitaLand Group for the financial year ending 31 December 2017.

None of the directors or the controlling shareholder of CapitaLand has any interest, direct or indirect, in the above.
