**SUCCESSFUL CLOSE OF SERIES 007 OF 3-MONTH  
DIGITAL SECURITIES COMMERCIAL PAPER  
– S\$31.82 MILLION GROSS PROCEEDS RAISED**

Amongst the subscribers, Madam Tan Hong Yee, Ms Yeah Lee Ching, Mr Yeah Chia Kai and Mr Yeah Chia Wei, who had subscribed for S\$10.50 million, S\$0.30 million, S\$0.26 million and S\$1.60 million respectively, amounting to 39.8% of the 3-month Series 007 Issuance. Madam Tan is a controlling shareholder and wife of Mr Yeah Hiang Nam, the Executive Chairman of the Company. Ms Yeah Lee Ching, Mr Yeah Chia Kai and Mr Yeah Chia Wei, are the Executive Director, the Chief Executive Officer and the Chief Credit and Risk Officer, respectively, of the Company and are children of Mr Yeah Hiang Nam.

The Company will make further announcements as and when there are other material developments in respect of the CP Facility and 3-month Series 007 Issuance.
