The Board of Directors of Abundance International Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that pursuant to Rule 704(15) of the Listing Manual Section B: Rules of Catalist of the Singapore Exchange Securities Trading Limited (the “**Catalist Rules**”), all the ordinary resolutions as set out in the Notice of Annual General Meeting dated 1 June 2020 were duly passed by the shareholders of the Company at the annual general meeting held on 23 June 2020 (the “**AGM**”).

Mr Jiang Hao, an Executive Director of the Company, was re-elected at the AGM. He remains as an Executive Director of the Company.

Mr Francis Yau Thiam Hwa, an Independent Director of the Company, was re-elected at the AGM. He remains as an Independent Director of the Company as well as Chairman of the Audit Committee and a member of each of the Remuneration Committee and the Nominating Committee and is considered independent of management for the purpose of Rule 704(7) of the Catalist Rules.

Abstention from voting

In relation to Resolution 2, the Re-election of Mr Jiang Hao as Director, whilst Mr Jiang Hao is not required to abstain from voting in respect of this resolution, as a matter of good corporate governance practice, Mr Jiang Hao, who is also a shareholder of the Company, had voluntarily abstained from voting his holdings of 117,600,000 shares on Ordinary Resolution 2 in respect of his own re-election as a Director of the Company.

In relation to Resolution 7, Renewal of Interested Person Transactions Mandate, Mr Shi Jiangang and his associates, who collectively hold 238,405,706 shares, abstained from voting. In addition, Mr Shi Jiangang and his associates also declined to accept appointment as proxy for any shareholder to vote in respect of the resolution as set out in the Notice of AGM unless the shareholder concerned had given specific instruction in his or her proxy form as to the manner in which his or her vote are to be cast in respect of the said resolution.

Name of firm and/or person appointed as scrutineer

Finova BPO Pte. Ltd. was appointed as the scrutineers for the polls conducted at the AGM.
