- (b) Member of the Nominating Committee (“**NC**”); and
- (c) Member of the Remuneration Committee (“**RC**”).

Mr Lai Kuan Loong, Victor, an Independent Director of the Company, is appointed as Chairman of the AC, a member of NC and a member of the RC, with effect from 31 July 2026, upon the conclusion of the AGM.
