- worked with the management of the Group to facilitate the subsidiaries' continued operations in accordance with the judicial management order, including discussions with the stakeholders of the Company to understand and maintain the ongoing business operations of the Group; and
- (ii) engaged in discussions with a potential investor, who has followed up on their interest with an indicative term sheet, on the terms of the investment and are currently working towards finalising a term sheet with this potential investor as soon as practicable.

The Judicial Managers would like to further update that they have filed for an extension of time of 90 days until 31 October 2022 to comply with the requirements under Section 107(1) and 107(2) of the Insolvency, Restructuring and Dissolution Act 2018. The hearing is fixed in the High Court on 1 August 2022 at 2.30 pm.
