On 11 October 2024, the Company announced a renounceable non-underwritten rights issue of up to 74,254,237 new ordinary shares in the capital of the Company ("Rights Shares"), at an issue price of S\$0.266 for each Rights Share on the basis of 10 Rights Shares for every 27 existing Shares ("Rights Issue").

The Rights Issue closed on 10 December 2024 and the 4,640,630 nil-paid Rights Shares provisionally allotted to Zheng Dazhai lapsed on the same date. The Rights Shares were issued and allotted on 16 December 2024.
