# LETTER TO SHAREHOLDERS ON ALTERNATIVE ARRANGEMENTS FOR THE ANNUAL GENERAL MEETING OF THE COMPANY TO BE HELD ON 23 APRIL 2021

Dear shareholders of Moya Holdings Asia Limited (the "Company"),

This letter is circulated together with and forms part of the Company's Notice of Annual General Meeting dated 8 April 2021 ("Notice of AGM") in respect of the upcoming Annual General Meeting of the Company ("AGM") scheduled to be held on Friday, 23 April 2021 at 10.00 a.m..

The board of directors (the "Board") of the Company refers to:

- 1) the COVID-19 (Temporary Measures) Act 2020 ("COVID-19 Act") which was passed by Parliament on 7 April 2020 which enables the Minister of Law by order to prescribe alternative arrangements for listed companies in Singapore to, inter alia, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means:
- 2) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 published on 13 April 2020 (amended on 14 April 2020, 24 April 2020, and 29 September 2020) ("COVID-19 Order") which was gazetted on 13 April 2020 and is deemed to have come into operation on 27 March 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies; and
- 3) the Joint Statement by the Accounting and Corporate Regulatory Authority, the Monetary Authority of Singapore and the Singapore Exchange Regulation which was issued on 13 April 2020 (and updated on 27 April 2020, 22 June 2020 and 1 October 2020), providing a checklist to guide listed and non-listed entities on the conduct of general meetings during the period when elevated safe distancing measures are in place.

The Company wishes to inform that it will be convening its upcoming AGM by way of electronic means pursuant to the First Schedule of the COVID-19 Order. As a precautionary measure to keep physical interactions and the COVID-19 transmission risk to a minimum, the Company will not be holding a physical meeting. Accordingly, **Shareholders will NOT be able to attend the AGM in person.** 

The Company will arrange for (i) a "live" audio-visual webcast of the AGM, which allows Shareholders to view the proceedings of the AGM contemporaneously ("LIVE WEBCAST"); and (ii) a "live" audio-only means, which allows Shareholders to observe the proceedings of the AGM contemporaneously ("LIVE AUDIO STREAM"). Shareholders can ONLY participate in the AGM via LIVE WEBCAST or LIVE AUDIO STREAM (collectively, the "electronic means).

#### PRE-REGISTRATION OF AGM

- For Shareholders who would like to view the proceedings of the AGM via LIVE WEBCAST or listen to the
  proceedings of the AGM through LIVE AUDIO STREAM, Shareholders will need to pre-register online at

  on 20 April 2021 (being not less than seventy-two (72) hours before the time appointed for holding the
  AGM) (the "Registration Deadline") to enable the Company to verify the Shareholders' status.
- 2. Authenticated Shareholders will receive an email confirmation by 22 April 2021 which contains a unique link to access the LIVE WEBCAST or the LIVE AUDIO STREAM to observe the proceedings of the AGM (via smartphones, tablets or laptop/computers).
- 3. Shareholders MUST NOT forward the abovementioned unique link to other persons who are not Shareholders and who are not entitled to attend the AGM. This is also to avoid any technical disruptions or overload to the LIVE WEBCAST and the LIVE AUDIO STREAM.

- 4. Shareholders, who would have been able to be appointed as proxies by relevant intermediaries under Section 181(1C) of the Companies Act, Chapter 50 of Singapore, such as CPF or SRS investors, should approach their respective agents, such as CPF Agent Banks or SRS Operators to participate in the AGM via electronic means.
- 5. Shareholders who register by the Registration Deadline but do not receive an email response by 22 April 2021 may contact the Company at <u>ir@moyaasia.com</u> for assistance.

## **DOCUMENTS FOR THE AGM**

Documents relating to the business of the AGM, which comprise the Company's annual report for the financial year ended 31 December 2020 as well as the Notice of AGM and the Proxy Form (as defined herein), have been published on SGXNet and the Company's corporate website at <a href="https://www.moyaasia.com">www.moyaasia.com</a> on 8 April 2021.

## **SUBMISSION OF QUESTIONS**

- 1. Shareholders will not be able to ask questions during the AGM via electronic means, and therefore it is important for Shareholders to submit their questions in advance of the AGM.
- 2. Shareholders may submit any questions they may have in advance in relation to any resolution set out in the Notice of AGM by 10.00 a.m. on 18 April 2021 via email to <a href="mailto:ir@moyaasia.com">ir@moyaasia.com</a> and provide their particulars as follows:
  - a) Full name (for individuals) / company name (for corporates) as per CDP/CPF/SRS Account records;
  - b) NRIC or Passport Number (for individuals) / Company Registration Number (for corporates);
  - c) Contact Number; and
  - d) Email Address.
- 3. The Company will provide responses to substantial queries and relevant comments from Shareholders relating to the agenda of the AGM prior to, or at, the AGM via electronic means. The Company will also address any subsequent clarifications sought, or follow-up questions, prior to, or at, the AGM in respect of substantial and relevant matters. The responses from the Board and management of the Company shall thereafter be published on SGXNet and the Company's corporate website at <a href="www.moyasia.com">www.moyasia.com</a>, together with the minutes of the AGM, within one (1) month after the conclusion of the AGM.
- 4. Shareholders, who would have been able to be appointed as proxies by relevant intermediaries under Section 181(1C) of the Companies Act, Chapter 50 of Singapore, such as CPF or SRS investors, should approach their respective agents, such as CPF Agent Banks or SRS Operators, to submit their questions in relation to any resolution set out in the Notice of AGM prior to the AGM and have their substantial queries and relevant comments answered.

### **PROXY VOTING**

- Voting at the AGM is by proxy ONLY. Please note that Shareholders will not be able to vote through the LIVE WEBCAST or LIVE AUDIO STREAM and can only vote with their proxy forms which are required to be submitted in accordance with the following paragraphs.
- Shareholders who wish to vote on any or all of the resolutions at the AGM must appoint the Chairman of the AGM as their proxy by completing the Proxy Form for the AGM. Shareholders should specifically indicate how they wish to vote for or vote against (or abstain from voting on) the resolutions set out in the Notice of AGM.
- 3. The instrument appointing the Chairman of the AGM as proxy, together with the power of attorney or other authority (if any) under which it is signed, or a notarial certified copy ("**Proxy Form**") thereof, must:
  - a) if submitted by email, be received by M & C Services Private Limited at gpb@mncsingapore.com; or

b) if submitted by post, be lodged at the office of the Company's Share Registrar, M & C Services Private Limited at 112 Robinson Road #05-01, Singapore 068902,

in either case, **by 10.00 a.m. on 20 April 2021** (being not less than seventy-two (72) hours before the time appointed for holding the AGM) and in default the Proxy Form for the AGM shall not be treated as valid.

- 4. In view of the current COVID-19 situation and the related safe distancing measures which may make it difficult for Shareholders to submit completed Proxy Forms by post, Shareholders are strongly encouraged to submit completed Proxy Forms electronically via email as early as possible, to enable your vote(s) to be counted, and to follow all government guidance and requirements.
- 5. CPF or SRS investors who wish to appoint the Chairman of the AGM respectively to act as their proxy should approach their respective CPF Agent Banks or SRS Operators to submit their votes to the Company (a) by email, be received by M & C Services Private Limited at <a href="mailto:gpb@mncsingapore.com">gpb@mncsingapore.com</a>; or (b) by post, be lodged at the office of the Company's Share Registrar, M & C Services Private Limited at 112 Robinson Road #05-01, Singapore 068902, at least seven (7) working days before the AGM (i.e. by 10.00 a.m. on 14 April 2021).

In view of the evolving COVID-19 situation, the Company reserves the right to take such further precautionary measures as may be appropriate up to the date of the AGM, including any precautionary measures required or recommended by the government or any regulatory bodies, in order to curb the spread of COVID-19.
