### RECEIPT OF THIRD PARTY NOTICE

---

The Board of Directors (the “**Board**”) of Huationg Global Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that on 3 August 2026, the Company’s wholly-owned subsidiary, Huationg Contractor Pte Ltd (“**Huationg Contractor**”), had been served with a third-party notice (the “**Third Party Notice**”), by Pan-United Concrete Pte Ltd (“**Pan-United**”). The Third Party Notice was served together with copies of the originating claim, the statement of claim and the defence, filed in HC/OC 606/2026 (the “**Suit**”) which was commenced by CJ Resources Pte. Ltd. (“**CJ Resources**”) against Pan-United in the General Division of the High Court of the Republic of Singapore (“**Court**”).

In the Suit, CJ Resources claims against Pan-United, among other things, the sum of S\$1,488,340.50 arising from an incident involving Barge MMS 003 which occurred at the Pulau Punggol Aggregate Terminal on or about 23 January 2024. In the Third Party Notice, Pan-United claims against Huationg Contractor to be indemnified against CJ Resources’ claim and the costs of the Suit, or contribution to the extent of CJ Resources’ claim that the Court deems fit and just.

Huationg Contractor will refute the allegations made in the Third Party Notice and has sought legal advice on this matter. Huationg Contractor will also strenuously defend its position against the allegations.

As at the date of this announcement, the Company does not expect the Suit to have a material impact on the Company’s earnings per share and net tangible assets per share for the current financial year ending 31 December 2026.

The Company will make the relevant update announcements in compliance with the Singapore Exchange Securities Trading Limited Listing Manual Section B: Rules of Catalist where there are developments on this matter.
