APPROVAL BY THE ACCOUNTING AND CORPORATE REGULATORY AUTHORITY ("ACRA") FOR THE COMPANY'S APPLICATION FOR EXTENSION OF TIME TO HOLD ITS ANNUAL GENERAL MEETING ("AGM") FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2020 ("FY2020")

The Board of Directors ("the **Board**") of TA Corporation Ltd (the "**Company**" and together with its subsidiaries, the "**Group**") refers to the Company's announcement dated 27 February 2021 in relation to the Company's application for extension of time to, *inter alia*, (i) hold its FY2020 AGM by 31 May 2021, and (ii) issuance of FY2020 annual report by 14 May 2021.
