ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN FOR THE ADVANCED DISTRIBUTION

13 April 2020 – Mapletree North Asia Commercial Trust Management Ltd., as manager (the "**Manager**") of Mapletree North Asia Commercial Trust ("**MNACT**"), wishes to announce that 11,175,826 new units in MNACT ("**Units**") will be issued at an issue price of S\$1.144 per unit pursuant to MNACT's distribution reinvestment plan ("**DRP**") in respect of MNACT's distribution for the period from 1 January 2020 to 27 February 2020 (the "**Advanced Distribution**") on 14 April 2020.

The new Units will be credited by 14 April 2020 to securities accounts of MNACT unitholders ("**Unitholders**") who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. on 14 April 2020.

The new Units will rank pari passu in all respects with the existing units.

Following the issuance of the new Units pursuant to MNACT's DRP for the Advanced Distribution, the total number of units in issue will increase from 3,342,916,300 to 3,354,092,126.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered mailing addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the Advanced Distribution in cash on 14 April 2020.
