## PARTICIPATION IN ANNUAL GENERAL MEETING ("AGM") BY ELECTRONIC MEANS

---

1. **Background:** Far East Orchard Limited (the "**Company**") refers to:
  - (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
  - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "**Order**") which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies; and
  - (c) the joint statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation (as at 1 October 2020) and the SGX FAQs on the Holding of General Meetings (as at 5 October 2020) which provides additional guidance on the conduct of general meetings.
2. **Date, time and conduct of AGM:** The Company's AGM will be convened and held by way of electronic means on **Monday, 26 April 2021 at 10.00 a.m.** (Singapore Time).
3. **Annual Report 2020, Sustainability Report 2020, Notice of AGM, Letter to Shareholders, Proxy Form:** All documents which relate to the business of the AGM are published on SGXNet at the URL <https://www.sgx.com/securities/company-announcements> and the Company's website at the URL <https://www.fareastorchard.com.sg/agm.html>. **Save for Notice of AGM and Proxy Form which will be sent by post to members, printed copies of other documents will not be despatched to members.** Members may request for printed copies of the Annual Report 2020 and Letter to Shareholders by completing and submitting the printed Request Form (which will be despatched with the printed copies of the Notice of AGM and the Proxy Form). Members are advised to check SGXNet and/or the Company's website regularly for updates.
4. **No personal attendance at the AGM:** Due to the current COVID-19 situation in Singapore, **shareholders will not be able to attend the AGM in person.**
5. **Participation at the AGM electronically:** Shareholders may participate at the AGM by:
  - (a) observing and/or listening to the AGM proceedings via "live" audio-visual webcast via their mobile phones, tablets or computers or "live" audio-only stream via telephone;
  - (b) submitting questions in advance of the AGM; and/or
  - (c) appointing the Chairman of the AGM ("**Chairman**") as proxy to attend, speak and vote on their behalf at the AGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGM are set out in the **Appendix** to this announcement.

6. **Persons who hold shares through relevant intermediaries (as defined in Section 181 of the Companies Act (Chapter 50 of Singapore)):**

- (a) CPF and SRS investors who wish to participate in the AGM by (i) observing and/or listening to the AGM proceedings via “live” audio-visual webcast or “live” audio-only stream; and (ii) submitting questions in advance of the AGM, should follow the steps for pre-registration and pre-submission of questions set out in the **Appendix**. However, CPF and SRS investors who wish to appoint the Chairman as proxy to attend, speak and vote on their behalf should approach their respective CPF Agent Banks or SRS Operators to submit their voting instructions by **5.00 p.m. on 14 April 2021**.
- (b) Investors holding shares through relevant intermediaries, who are not CPF or SRS investors, who wish to participate in the AGM by (i) observing and/or listening to the AGM proceedings via “live” audio-visual webcast or “live” audio-only stream; (ii) submitting questions in advance of the AGM; and/or (iii) appointing the Chairman as proxy to attend, speak and vote on their behalf at the AGM, should contact their relevant intermediary soonest in order to make the necessary arrangements for them to participate in the AGM.

### Steps for pre-registration, pre-submission of questions and voting at the AGM

Shareholders will be able to observe and/or listen to the AGM proceedings through a “live” audio-visual webcast or “live” audio-only stream (after pre-registration), submit questions in advance of the AGM and vote by appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

3	<b>Submission of Proxy Form to vote</b>	<p><b>Appointment of Chairman as proxy:</b> A shareholder (whether individual or corporate) must appoint the Chairman of the Meeting as his/her/its proxy to attend, speak and vote on his/her/its behalf at the AGM, if such shareholder wishes to exercise his/her/its voting rights.</p> <p><b>Specific voting instructions to be given:</b> Where a shareholder (whether individual or corporate) appoints the Chairman of the Meeting as his/her/its proxy, he/she/it must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the proxy form, failing which the appointment of the Chairman of the Meeting as proxy for that resolution will be treated as invalid.</p> <p><b>Submission of proxy forms:</b> Proxy forms must be submitted in the following manner:</p> <p>(a) if submitted by post, be lodged at the office of the Company's Share Registrar, Boardroom Corporate &amp; Advisory Services Pte Ltd, at 50 Raffles Place, #32-01 Singapore Land Tower, Singapore 048623; or</p> <p>(b) if submitted electronically, be submitted via email to the Company's Share Registrar at <a href="mailto:srs.teamc@boardroomlimited.com">srs.teamc@boardroomlimited.com</a>,</p> <p>in either case, by <b>10.00 a.m. on 23 April 2021</b>.</p> <p>A shareholder who wishes to submit a proxy form (whether received by post or downloaded from the Company's website or SGXNet) is to complete and sign the proxy form, before submitting it by post, or before scanning and sending it by email, in the manner described above.</p> <p>In view of the current COVID-19 situation and the related safe distancing measures, <b>members are strongly encouraged to submit completed proxy forms electronically via email</b>.</p> <p>The proxy form is not valid for use by investors holding shares through relevant intermediaries (as defined in Section 181 of the Companies Act). Such investor who wishes to vote should instead approach his/her relevant intermediary soonest to specify his/her voting instructions. CPF or SRS investors who wish to appoint the Chairman of the Meeting as proxy should approach their respective CPF Agent Banks or SRS Operators to submit their votes by <b>5.00 p.m. on 14 April 2021</b>.</p>
