Berhad ("SHCSB"), by virtue of his interest in SHCSB; and (ii) 3,627,000 shares in the capital of SHC Asia held by Allcare, by virture of his interest in SHCSB has a 74.23% interest in Allcare, and SHCH, which is a wholly-owned subsidiary of SHCSB, has a 25.77% interest in Allcare.

Immediately after the Transaction, Mr Teo. Soo Chew is deemed interested in the 249,639,317 shares in the capital of SHC Asia held by SHCPL, representing 81.59% of the total number of voting shares in SHC Asia, by virtue of his interests in SHCSB.
