## **RESIGNATION OF DIRECTOR RECONSTITUTION OF AUDIT COMMITTEE AND NOMINATING COMMITTEE**

**Singapore, 29 April 2015**

The Board of Directors (the "Board") of Boustead Singapore Limited ("Boustead" or the "Company") refers to the circular to shareholders dated 31 March 2015 in relation to the proposed demerger of the real estate solutions business through the *dividend in specie* of approximately (but not exceeding) 49.0% of the issued shares in Boustead Projects Limited ("Boustead Projects") to shareholders (the "BP Distribution") and the proposed listing of Boustead Projects Limited on the Main Board of the Singapore Exchange Securities Trading Limited ("SGX-ST") by way of an introduction (the "Circular").

Mr John Lim Kok Min is currently the Chairman and Independent Non-Executive Director of Boustead Projects and so as not to affect his independence in Boustead Projects, the Board and Mr John Lim Kok Min have agreed that in the event of the listing of Boustead Projects on the SGX-ST, Mr John Lim Kok Min will relinquish his position on the Board as stated in paragraph 2.1.6 of the Circular.

It is noted that at the Extraordinary General Meeting of the Company held on 16 April 2015, the shareholders of the Company had approved, *inter alia*, the BP Distribution and following such approval, the shares of Boustead Projects will be listed on the Main Board of the SGX-ST at 9.00 am on 30 April 2015.

Accordingly, the Board wishes to announce that Mr John Lim Kok Min has today relinquished his role as an Independent Non-Executive Director of the Company. The Board would like to take this opportunity to thank Mr. John Lim Kok Min for his past services and contribution to the Company.

As a consequence of Mr John Lim relinquishing his position on the Board, he will also vacate his roles on the Audit, Nominating and Remuneration Committees. The Board has today appointed Mr Goh Boon Seong as the Chairman of the Audit Committee and a member of the Nominating Committee. The Board of Directors considers Mr Goh Boon Seong to be an independent Director for the purposes of Rule 704(8) of the Listing Manual of SGX-ST.
