Temasek's deemed interest arises via 88,000,000 shares held by StarHub. StarHub is a subsidiary of Asia Mobile Holdings Pte. Ltd. which is a subsidiary of Asia Mobile Holding Company Pte. Ltd. which is a subsidiary of STT Communications Ltd which is a subsidiary of STT which is a subsidiary of Temasek.

STT and StarHub are independently managed Temasek portfolio companies. Temasek is not involved in their business or operating decisions, including those regarding StarHub's position in shares of the Listed Issuer.
