On 24 April 2020, in connection with the merger of Frasers Commercial Trust ("FCOT") and FLT (the "Merger"), an aggregate of 1,130,191,302 FLT Units were allotted and issued to unitholders of FCOT, as part consideration for all units in FCOT (the "Settlement"). Immediately following the Settlement, as the number of FLT Units which FPITH holds has remained the same, the percentage of such units relative to the total number of FLT Units has decreased from 19.29% to 12.86%.
