On 13 March 2024, Maxtop Management Corp ("Maxtop") entered into a sale and purchase agreement with Golden Capital (Singapore) Limited ("Golden Capital"), pursuant to an internal restructuring which Maxtop disposed of 1,776,627,762 THBEV Shares to Golden Capital. Following this, Golden Capital had an interest in an aggregate of 1,776,627,762 THBEV Shares, and Maxtop ceased to hold any interest in THBEV Shares.

Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi jointly hold a 100% direct interest in MM Group Limited, which owns a 100% direct interest in Golden Capital. Each of Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all of the THBEV Shares in which Golden Capital have an interest.

Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi also jointly hold a 51% direct interest in Siritwana Co., Ltd ("Siritwana"). Siritwana holds a direct interest in 11,368,060,000 THBEV Shares. Siritwanan Co., Ltd. ("Siritwanan") holds a direct interest in 3,400,000,000 THBEV Shares. Siritwanan is a wholly-owned subsidiary of Siritwana.

Each of Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all of the THBEV Shares in which Siritwana and Siritwanan have an interest.
