## ALLOTMENT AND ISSUANCE OF NEW SHARES PURSUANT TO THE VESTING OF SHARE AWARDS GRANTED ON 19 DECEMBER 2023 UNDER THE TALKMED GROUP PERFORMANCE SHARE PLAN (“PSP”)

The Board of Directors (the “**Board**” or “**Directors**”) of TalkMed Group Limited (the “**Company**”, together with its subsidiaries, collectively, the “**Group**”) refers to the Company’s announcement dated 19 December 2023 in relation to the grant of share awards pursuant to the PSP (“**Share Awards**”).
